**EMERGENCY OVERVIEW: Product Description:** This product is a clear, colorless liquid with a faint ethereal odor, which is shipped under pressure with a proprietary gas mixture. **Health Hazards:** The main acute health hazard associated with this product is irritation of eyes and possible frostbite if contents of cylinder are rapidly released. Inhalation may be harmful. High concentrations may present an asphyxiation hazard if released in confined spaces. May cause irritation to the eyes. Inhalation may cause adverse effects on the central nervous system, cardiac sensitization and abnormal heart rate. Chronic exposure may cause damage to the liver. **Flammability Hazards:** This compound is not flammable, but can decompose at very high temperatures forming toxic gases such as hydrogen fluoride, carbonyl fluorides and other compounds given in Section 5 (Fire-Fighting Measures). Cylinders or tanks may rupture and explode if heated. **Reactivity Hazards:** This gas can react vigorously or violently with alkaline metals and earth metals. **Environmental Hazards:** The 2,2-Dichloro-1,1,1-Trifluoroethane component can cause destruction to the ozone layer and can contribute to global warming. **Emergency Response Considerations:** Emergency responders must wear the proper personal protective equipment suitable for the situation to which they are responding. **WARNING**—If rescue personnel need to enter an area suspected of having a low level of oxygen, they should be equipped with Self-Contained Breathing Apparatus (SCBA) and appropriate personal protective equipment.

## SECTION 4. FIRST AID MEASURES

**PROTECTION OF FIRST AID RESPONDERS:** RESCUERS SHOULD NOT ATTEMPT TO RETRIEVE VICTIMS OF EXPOSURE TO THIS PRODUCT WITHOUT ADEQUATE PERSONAL PROTECTIVE EQUIPMENT. Self-Contained Breathing Apparatus should be worn if the level of oxygen cannot be determined. Rescuers should be taken for medical attention, if necessary. Only trained personnel should administer supplemental oxygen and/or cardio-pulmonary resuscitation, if necessary.

**SECTION 4. FIRST AID MEASURES (Continued)**

**DESCRIPTION OF FIRST AID MEASURES:** Remove victim(s) to fresh air, as quickly as possible. Take copy of label and SDS to physician or other health professional with victim(s).

**Inhalation Exposure:** If inhaled, remove victim to fresh air. If necessary, use artificial respiration to support vital functions. Seek medical attention if adverse effect occurs after removal to fresh air.

**Skin Exposure:** If this product contaminates the skin, immediately begin decontamination with running water. Minimum flushing is for 20 minutes. Remove exposed or contaminated clothing, taking care not to contaminate eyes. If this product contaminates the skin, immediately begin decontamination with running water. Minimum flushing is for 20 minutes. Remove exposed or contaminated clothing, taking care not to contaminate eyes. Victim must seek immediate medical attention. Remove any clothing that may restrict circulation to any frozen area. Do not rub frozen parts as tissue damage may occur. As soon as practicable, place any affected area in warm water bath which has a temperature that does not exceed 105°F (40°C). NEVER USE HOT WATER. NEVER USE DRY HEAT. If area of frostbite is extensive, and if possible, remove clothing while showering with warm water. If warm water is not available, or is impractical to use, wrap the affected parts gently in blankets. Alternatively, if the fingers or hands are frostbitten, place the affected area of the body in the armpit. Encourage victim to gently exercise the affected part while being warmed. Frozen tissue is painless and appears waxy, with a possible yellow color. Frozen tissue will become swollen, painful and prone to infection when thawed. If the frozen part of the body has been thawed by the time medical attention has been obtained, cover the area with a dry sterile dressing and a large bulky protective covering.

**Eye Exposure:** If mechanical injury occurs, cover eye with bandage and seek appropriate medical attention. If rapid release has caused frostbite, cover injured eye; an ophthalmologist should be sought as soon as possible.

**Ingestion:** Ingestion is an unlikely route of exposure for this gas.

**MEDICAL CONDITIONS AGGRAVATED BY OVEREXPOSURE:** Heart conditions and liver disorders.

**INDICATION OF IMMEDIATE MEDICAL ATTENTION AND SPECIAL TREATMENT IF NEEDED:** Administer oxygen, if necessary, and treat symptoms. This gas is an asphyxiant and can induce cardiac muscle sensitization to circulating epinephrine-like compounds. Because of possible disturbances of cardiac rhythm, catecholamine drugs, such as epinephrine, that may be used in situations of emergency life support should be used with special caution. Do NOT give adrenalin or similar sympathomimetic drugs. Do NOT allow victim to exercise until 24 hours following specific exposures. Freeze burns of mucosal tissue can develop following specific exposures.

**SECTION 5. FIRE FIGHTING MEASURES**

**SPECIFIC HAZARDS ARISING FROM THE PRODUCT:** This product does not burn; however, containers, when involved in fire, may rupture or burst in the heat of the fire. Most cylinders have a pressure release device, which will vent contents if the cylinder is exposed to high temperatures. Vapors heavier than air, creating an asphyxiation hazard in low areas or confined spaces.


**EXPLOSION SENSITIVITY TO MECHANICAL IMPACT:** Not sensitive.

**EXPLOSION SENSITIVITY TO STATIC DISCHARGE:** Not sensitive.

**HAZARDOUS COMBUSTION PRODUCTS:** Combustion or decomposition products include phosgene, fluorine gas, hydrogen fluoride, hydrogen chloride, and tetrafluoroethylene, hydrochloric and hydrofluoric acids, and possibly carbonyl halide and carbon oxides. These by-products can be dangerous even in low concentrations and in sufficient concentrations can result in personal injury or death.

**SPECIAL PROTECTIVE ACTIONS FOR FIRE-FIGHTERS:** Move fire-exposed containers if it can be done without risk to firefighters. Use water spray to cool fire-exposed cylinders. Take care not to block pressure relief valves. Stay away from ends of tanks (but realize that shrapnel may travel in any direction). Withdraw immediately in case of rising sound from venting safety device or any discoloration of tanks due to fire.

**SECTION 6. ACCIDENTAL RELEASE MEASURES**

**PERSONAL PRECAUTIONS AND EMERGENCY PROCEDURES:** Evacuate immediate area. Uncontrolled releases should be responded to by trained personnel using pre-planned procedures. Vapors from liquefied gas are initially heavier than air and spread along ground, creating an oxygen-deficient atmosphere in low-lying areas or confined spaces. Detection systems should be available to monitor for level of oxygen. The level of oxygen should be above 19.5% before personnel can be allowed in the area without SCBA.

**PERSONAL PROTECTIVE EQUIPMENT:** Proper protective equipment should be used.

**All Releases:** Minimum Personal Protective Equipment should be **Level B: Self-Contained Breathing Apparatus**. Note: chemically protective clothing may provide little or no thermal protection against the hazard of frostbite. The atmosphere must at least 19.5 percent oxygen before non-emergency personnel can be allowed in the area without Self-Contained Breathing Apparatus and fire protection. If gas is leaking incidentally from the cylinder or its valve, contact your supplier.

**SECTION 6. ACCIDENTAL RELEASE MEASURES**

**METHODS FOR CLEAN-UP AND CONTAINMENT:**

**All Releases:** In the event of a release of this product, operator should close the gas source if possible to do so safely. Evacuate area in the event of a significant release. Locate and seal the source of the leaking gas. If leak is in user's gas handling equipment or system, close cylinder valve, and safely vent high pressure before attempting repairs. If leak is from the cylinder, cylinder valve or the valve pressure relief device (PRD), contact your supplier. If this does not stop the release (or if it is not possible to reach the valve), allow the gas to release in-place or remove it to a safe area and allow the gas to be released there. Call CHEMTREC (1-800-424-9300) for emergency assistance. Or if in Canada, call CANUTEC (613-996-6666).

**ENVIRONMENTAL PRECAUTIONS:** All release to the environment should be avoided as this gas has global warming potential. Run-off water may be contaminated by other materials and should be contained to prevent possible environmental damage.

**REFERENCE TO OTHER SECTIONS:** See information in Section 8 (Exposure Controls – Personal Protection) and Section 13 (Disposal Considerations) for additional information.

**SECTION 7. HANDLING AND STORAGE**

**PRECAUTIONS FOR SAFE HANDLING: WARNING:** Do not vent to the atmosphere. Contains 2,2-Dichloro-1,1,1-Trifluoroethane, which can cause destruction of the ozone layer. Releases of this gas can create an oxygen-deficient atmosphere. Be aware of any signs of dizziness or fatigue; exposures to fatal concentrations could occur without any significant warning symptoms, due to oxygen-deficiency. All work operations should be monitored in such a way that emergency personnel can be immediately contacted in the event of a release. Wearing contact lenses is not recommended when handling this gas.

Cylinder valves should be inspected regularly for physical damage or corrosion (apparent by discoloration or rust). Care should be taken to inspect the following valve locations for corrosion: neck (where valve inserts into cylinder); bonnet nut (where handle attaches to valve body). Close valve after each use and when empty.

Do not drag, roll, slide or drop cylinder. Use a suitable hand truck designed for cylinder movement. Never attempt to lift a cylinder by its cap. Secure cylinders at all times while in use. Use a pressure regulator to safely discharge product from cylinder. Use a check valve to prevent reverse flow into cylinder. Once cylinder has been connected to properly purged process, open cylinder valve slowly and carefully. If user experiences any difficulty operating cylinder valve, discontinue use and contact supplier. Never insert an object (e.g., wrench, screwdriver, etc.) into valve cap openings; doing so may damage valve, causing a leak to occur. Use an adjustable strap-wrench to remove over-tight or rusted caps.

Do not heat cylinders by any means to increase the discharge rate of product from the cylinder. Never apply flame or localized heat directly to any part of the cylinder. Cylinders should not be artificially cooled as certain types of steel undergo property changes when cryogenically cooled, thus making the cylinder unstable.

**CONDITIONS FOR SAFE STORAGE:** Always store and handle compressed gas cylinders in accordance with Compressed Gas Association, Inc. at [www.cganet.com](http://www.cganet.com) pamphlet CGA P-1, *Safe Handling of Compressed Gases in Containers*. Local regulations may require specific equipment for storage and use. Cylinders should be stored upright and be firmly secured to prevent falling or being knocked-over. Cylinders can be stored in the open, but in such cases, should be protected against extremes of weather and from the dampness of the ground to prevent rusting. Cylinders should be stored in dry, well-ventilated areas away from sources of heat, ignition and direct sunlight. Do not allow area where cylinders are stored to exceed 52°C (125°F). Store containers away from heavily trafficked areas and emergency exits. Isolate from other non compatible chemicals (refer to Section 10, Stability and Reactivity). Store away from process and production areas, away from elevators, building and room exits or main aisles leading to exits. Protect cylinders against physical damage. Full and empty cylinders should be segregated. Use a first-in, first-out inventory systems to prevent full containers from being stored for long periods of time. **NOTE:** Use only DOT or ASME code cylinders designed for compressed gas storage. Cylinders must not be recharged except by or with the consent of owner.

**STANDARD VALVE CONNECTIONS FOR U.S. AND CANADA:** Use the proper CGA connections, DO NOT USE ADAPTERS:

**PRODUCT USE:** This product is used as a fire-extinguishing agent, refrigerant gas and as a cleaning agent.

**PROTECTIVE PRACTICES DURING MAINTENANCE OF CONTAMINATED EQUIPMENT:** Follow practices indicated in Section 6 (Accidental Release Measures). Relieve pressure before attempting repairs.

**WARNING PROPERTIES FOR THIS PRODUCT:** There are no good properties to act as a warning of a release. In terms of leak detection, fittings and joints can be painted with a soap solution to detect leaks, which will be indicated by a bubble formation.

**SECTION 10. STABILITY AND REACTIVITY**

**CHEMICAL STABILITY:** Stable under conditions of normal pressure and temperature.

**CONDITIONS TO AVOID:** Cylinders should not be exposed to temperatures in excess of 125°F (52°C).

**MATERIALS WITH WHICH GAS IS INCOMPATIBLE:** Avoid contact with acids, strong alkali or alkaline earth metals, finely powdered metals such as aluminum, magnesium or zinc and strong oxidizers, since they may react or accelerate decomposition. Any source of high temperature, such as lighted cigarettes, flames, hot spots or welding may yield toxic and/or corrosive decomposition products. When pressurized with air or oxygen, the mixture may become flammable. Certain mixtures of HCFCs or HFCs with chlorine may become flammable or reactive under certain conditions.

**POSSIBILITY OF HAZARDOUS REACTION OR POLYMERIZATION:** Polymerization will not occur. May cause strong exothermic reaction when exposed to freshly abraded aluminum surfaces at very high temperatures or high pressure. Chemically active metals: potassium, calcium, powdered aluminum, magnesium and zinc.

**SECTION 11. TOXICOLOGICAL INFORMATION**

**ROUTES OF ENTRY, SYMPTOMS OF ACUTE EXPOSURE:** WARNING-If rescue personnel need to enter an area in which a release of this compound has occurred, they should be equipped with Self-Contained Breathing Apparatus (SCBA) and appropriate personal protective equipment. High concentration of this gas will create an oxygen-deficient atmosphere, creating the risk of asphyxiation.

**Eye Contact:** Release of a high-pressure gas may result in airborne objects.

**Ingestion:** Ingestion of this compound is not a likely route of industrial exposure.

**Inhalation:** Inhalation of high concentrations of this gas may lead to heart arrhythmias. High concentrations of this gas can cause an oxygen-deficient environment. Individuals breathing such an atmosphere may experience symptoms which include headaches, ringing in ears, dizziness, drowsiness, unconsciousness, nausea, vomiting, and depression of all the senses. The skin of a victim may have a blue color. Under some circumstances of over-exposure, death may occur, due to the displacement of oxygen. The effects associated with various levels of oxygen are described below.

**EXPOSURE SYMPTOM**

Normal oxygen concentration in air.

Decreased ability to perform tasks. May impair coordination and may induce early symptoms in persons with heart, lung, or circulatory problems.

8 minutes, may be fatal in 50–100% of cases; 6 minutes, may be fatal in 25 to 50% of cases; 4–5 minutes, recovery with treatment.

Coma in 40 seconds, followed by convulsion, breathing failure, death.

**WARNING:** Exposure to atmospheres containing 8–10% or less oxygen will bring about unconsciousness without warning and so quickly that individuals cannot help or protect themselves. Lack of sufficient oxygen may cause serious injury or death.

Inhalation may cause an increase in the sensitivity of the heart to adrenaline, which could result in irregular or rapid heartbeats.

**Skin Contact:** Transitory skin contact should not cause any adverse effects.

**OTHER ACUTE HEALTH EFFECTS:** Contact with rapidly expanding gases (which are released from under high pressure) may cause frostbite. Symptoms of frostbite include change in skin color to white or grayish-yellow. The pain caused by frostbite can quickly subside, masking the injury. In addition, the sudden release of a pressurized gas (such as may occur in the event of a valve failure), presents a severe hazard of mechanical injury. Misuse or intentional inhalation abuse may cause death without warning symptoms, due to cardiac effects. The most relevant critical effects for a single, brief exposure to 2,2-Dichloro-1,1,1-Trifluoroethane are central nervous system depression and increased likelihood of epinephrine induced cardiac arrhythmia.

**ACUTE EXPOSURE TARGET ORGANS:** Respiratory system.

**ROUTES OF ENTRY, SYMPTOMS OF CHRONIC EXPOSURE:**

**Inhalation:** Chronic exposure to oxygen-deficient atmospheres (below 18% oxygen in air) may affect the heart and nervous system. Inhalation of very high concentration may cause adverse effects on the central nervous system. At concentrations of 20,000 ppm or higher, the 2,2-Dichloro-1,1,1-Trifluoroethane component may cause increased sensitivity of the heart to adrenaline which might cause irregular heart beats and possible ventricular fibrillation or death. Long-term exposure to concentrations above those time weighted averages recommended may cause liver damage with altered enzyme levels and central nervous system depression. Cases of manifest or subclinical liver disease associated with repeated occupational exposures to 2,2-Dichloro-1,1,1-Trifluoroethane vapors at 5-1125 ppm (31.3-7030 mg/m<sup>3</sup>) for 1-4 months. Acute liver dysfunction has been reported among workers repeatedly exposed to 2,2-dichloro-1,1,1-trifluoroethane. Causality between occupational exposure to 2,2-dichloro-1,1,1-trifluoroethane and liver dysfunction was examined.

**ROUTES OF ENTRY, SYMPTOMS OF CHRONIC EXPOSURE (continued):**

**Inhalation (continued):** Levels of exposure to 2,2-dichloro-1,1,1-trifluoroethane were estimated retrospectively by reproducing working conditions and by a job record survey. Health surveillance, including liver function and subjective symptoms, was done when two workers first complained of ill health. The mean 2,2-dichloro-1,1,1-trifluoroethane concentration in air was more than 200 ppm with a peak concentration of about 1,000 ppm in a processing area where 2,2-dichloro-1,1,1-trifluoroethane was used. 2,2-dichloro-1,1,1-trifluoroethane of 1824 ppm was detected in the adjunct areas where 2,2-dichloro-1,1,1-trifluoroethane vapor was not generated. Workers (n=14) were then classified into high (n=5) and low (n=9) exposure groups according to the estimated exposure level, which was confirmed by determination of urinary trifluoroacetic acid. Mean serum AST and ALT levels were 236 IU/l and 476 IU/l among the high-exposed workers, and exceeded 500 IU/l in three workers. Various types of symptoms involving the central nervous system and digestive organs, and irritation of the mucous membrane, were also experienced. The degree and prevalence of these health effects were higher in the high exposure group, which indicates the exposure-effect and exposure-response relationships. The consistency and temporality of the relationship between 2,2-dichloro-1,1,1-trifluoroethane exposure and the observed health effects were also confirmed. Repeated exposure to high concentrations of 2,2-dichloro-1,1,1-trifluoroethane for no more than five weeks causes acute severe liver dysfunction with various symptoms in humans. Biological plausibility must be clarified to confirm the causality.

Long-term exposure in a two year study (6 hours/day, 5 days/week) at concentrations of 300, 1000 and 5000 ppm decreased body weight, serum cholesterol, triglycerides and glucose, and increased urinary fluoride concentrations in rats. However, survival was significantly improved in all exposed groups compared to control animals.

**Skin Contact:** None known.

**Chronic Exposure Target Organs:** Cardiac system, central nervous system, liver.

**CARCINOGENIC POTENTIAL:** In a 2 year inhalation study in rats involving the 2,2,-Dichloro-1,1,1-Trifluoromethane component, inhalation of 300, 1000 and 5000 ppm caused an increase in benign tumors of the liver, pancreas, and testis. Tumors occurred late in life and none were assessed to be life threatening. Tumor formation is thought to occur through non-genotoxic mechanisms associated with a peroxisome proliferating potential or with hormonal disturbances in older rats. This compound is not listed as a carcinogen or as potential carcinogen on EPA, NIOSH, GERMAN MAK, OSHA, NTP, IARC, or CAL/OSHA Carcinogen lists.

**ADDITIONAL TOXICOLOGICAL DATA:** Inhalation of high concentration may lead to unconsciousness and possible death. Effects of overexposure by inhalation may include non specific discomfort, such as nausea, headache, or weakness, or temporary central nervous system depression with effects such as dizziness, headache, confusion, loss of coordination, and loss of consciousness. Higher exposures by inhalation may cause temporary alteration of the heart's electrical activity with irregular pulse, palpitations, or inadequate circulation. Individuals with pre-existing diseases of the central nervous or cardiovascular system may have increased susceptibility to the toxicity of excessive exposure. Rodent studies indicate 2,2-Dichloro-1,1,1-Trifluoroethane is easily absorbed via inhalation. It distributes in all organs, more so in the liver. About 90% of inhaled material is eliminated via the lungs unchanged. The remaining amount is metabolized to trifluoroacetic acid and excreted in the urine. Small amounts of trifluoroacetylated proteins were detected in rats in laboratory studies.

**IRRITANCY OF PRODUCT:** This product is irritating to the eyes.

**SENSITIZATION OF PRODUCT:** This compound is not a human skin or respiratory sensitizer. Inhalation may cause cardiac sensitization and abnormal heartbeat.

**REPRODUCTIVE TOXICITY INFORMATION:** This compound has not reported to cause embryotoxic, teratogenic or reproductive toxicity effects in humans. The following information is available from animal studies.

**Mutagenicity:** There was some evidence of clastogenic activity in human lymphocytes exposed to 2,2-Dichloro-1,1,1-Trifluoroethane at high cytotoxic concentration *in vitro*. *In vitro* and *in vivo* tests for genetic toxicity were negative in animal studies.

**Embryotoxicity/Teratogenicity:** There was no evidence that 2,2-Dichloro-1,1,1-Trifluoroethane is teratogenic in laboratory animals or induces reproductive or fetal toxicity at levels of exposure lower than those that cause other systemic effects. Growth was retarded in neonatal rats and monkeys reared by dams exposed to 2,2-Dichloro-1,1,1-Trifluoroethane.

**Reproductive Toxicity:** The main metabolite of 2,2-Dichloro-1,1,1-Trifluoroethane, trifluoroacetic acid, was found in the milk of dams in animal studies.

**BIOLOGICAL EXPOSURE INDICES (BEIs):** Currently, Biological Exposure Indices (BEIs) have not been determined for components.

**MOBILITY:** This gas mixture has not been tested. The following information is available for the 2,2-dichloro-1,1,1-trifluoroethane component.

Using a structure estimation method based on molecular connectivity indices, the Koc of 2,2-dichloro-1,1,1-trifluoroethane can be estimated to be 140. According to a classification scheme, this estimated Koc value suggests that 2,2-dichloro-1,1,1-trifluoroethane is expected to have high mobility in soil.

**PERSISTENCE AND BIODEGRADABILITY:** This gas mixture has not been tested. The following information is available for the 2,2-dichloro-1,1,1-trifluoroethane component.

If released to air, a vapor pressure of 718 mm Hg at 25°C indicates 2,2-dichloro-1,1,1-trifluoroethane will exist solely as a vapor in the ambient atmosphere. Vapor-phase 2,2-dichloro-1,1,1-trifluoroethane will be degraded in the atmosphere by reaction with photochemically-produced hydroxyl radicals; the half-life for this reaction in air is about 2.2 years. 2,2-dichloro-1,1,1-trifluoroethane does not contain chromophores that absorb at wavelengths >290 nm and, therefore, is not expected to be susceptible to direct photolysis by sunlight in the troposphere. 2,2-Dichloro-1,1,1-trifluoroethane is fairly soluble in water and may be removed from the air by rain. If released to soil, 2,2-dichloro-1,1,1-trifluoroethane is expected to have high mobility based upon an estimated Koc of 140. Volatilization from moist soil surfaces is an important fate process based upon a Henry's Law constant of 0.0256 atm-cu m/mole. 2,2-Dichloro-1,1,1-trifluoroethane is expected to volatilize from dry soil surfaces based upon its vapor pressure. Primary and ultimate degradation of 24% and 10%, respectively, using the Closed Bottle test suggest that biodegradation is not a fast environmental fate process in soil or water. If released into water, 2,2-dichloro-1,1,1-trifluoroethane is not expected to adsorb to suspended solids and sediment based upon the estimated Koc. Volatilization from water surfaces is expected to be an important fate process based upon this compound's Henry's Law constant. Estimated volatilization half-lives for a model river and model lake are 3.7 hours and 4.9 days, respectively. An estimated BCF of 13 suggests the potential for bioconcentration in aquatic organisms is low. Hydrolysis is not expected to be an important environmental fate process based on estimated hydrolysis half-lives at pH 7 and 8 of 134 and 13 years, respectively.

**POTENTIAL TO BIOACCUMULATE:** This gas mixture has not been tested. The following information is available for the 2,2-dichloro-1,1,1-trifluoroethane component.

An estimated BCF of 13 was calculated in fish for 2,2-dichloro-1,1,1-trifluoroethane, using an estimated log Kow of 2.17 and a regression derived equation. According to a classification scheme, this BCF suggests the potential for bioconcentration in aquatic organisms is low.

**ECOTOXICITY:** Immediate adverse effect on plants would be related to oxygen-deficient environments or frost from rapidly expanding gases. The 2,2-dichloro-1,1,1-trifluoroethane component is moderately to slightly toxic to aquatic organisms. However, due to its limited solubility and high volatility, it is not considered a threat to aquatic life. The following aquatic toxicity data is available for this compound.

A mass explosion is one that affects almost the entire load instantaneously. *Compressed Gases:* No Rating. *Pyrophorics:* Add to the definition of Flammability "4". *Oxidizers:* No "4" rating. *Unstable Reactives:* Substances that may polymerize, decompose, condense or self-react at ambient temperature and/or pressure and have a high potential to cause significant heat generation or explosion).

**NATIONAL FIRE PROTECTION ASSOCIATION HAZARD RATINGS:**

**HEALTH HAZARD: 0 (materials that, under emergency conditions, would offer no hazard beyond that of ordinary combustible materials):** Gases and vapors whose LC<sub>50</sub> for acute inhalation toxicity is greater than 10,000 ppm. Dusts and mists whose LC<sub>50</sub> for acute inhalation toxicity is greater than 200 mg/L. Materials whose LD<sub>50</sub> for acute dermal toxicity is greater than 2000 mg/kg. Materials whose LD<sub>50</sub> for acute oral toxicity is greater than 2000 mg/kg. Materials that are essentially non-irritating to the respiratory tract, eyes and skin. 1 (materials that, under emergency conditions, can cause significant irritation): Gases and vapors whose LC<sub>50</sub> for acute inhalation toxicity is greater than 5,000 ppm but less than or equal to 10,000 ppm. Dusts and mists whose LC<sub>50</sub> for acute inhalation toxicity is greater than 10 mg/L but less than or equal to 200 mg/L. Materials whose LD<sub>50</sub> for acute dermal toxicity is greater than 1000 mg/kg but less than or equal to 2000 mg/kg.

**HEALTH HAZARD (continued): 1 (continued):** Materials whose LD<sub>50</sub> for acute oral toxicity is greater than 500 mg/kg but less than or equal to 2000 mg/kg. Materials that cause slight to moderate irritation to the respiratory tract, eyes and skin. **2** (materials that, under emergency conditions, can cause temporary incapacitation or residual injury): Gases and vapors whose LC<sub>50</sub> for acute inhalation toxicity is greater than 3,000 ppm but less than or equal to 5,000 ppm. Dusts and mists whose LC<sub>50</sub> for acute inhalation toxicity is greater than 2 mg/L but less than or equal to 10 mg/L. Materials whose LD<sub>50</sub> for acute dermal toxicity is greater than 200 mg/kg but less than or equal to 1000 mg/kg. Materials whose LD<sub>50</sub> for acute oral toxicity is greater than 50 mg/kg but less than or equal to 500 mg/kg. Any liquid whose saturated vapor concentration at 20°C (68°F) is equal to or greater than one-fifth its LC<sub>50</sub> for acute inhalation toxicity, if its LC<sub>50</sub> is less than or equal to 5000 ppm and that does not meet the criteria for either degree of hazard 3 or degree of hazard 4. Compressed liquefied gases with boiling points between -30°C (-22°F) and -55°C (-66.5°F) that cause severe tissue damage, depending on duration of exposure. Materials that are respiratory irritants. Materials that cause severe, but reversible irritation to the eyes or are lachrymators. Materials that are primary skin irritants or sensitizers. **3** (materials that, under emergency conditions, can cause serious or permanent injury): Gases and vapors whose LC<sub>50</sub> for acute inhalation toxicity is greater than 1,000 ppm but less than or equal to 3,000 ppm. Dusts and mists whose LC<sub>50</sub> for acute inhalation toxicity is greater than 0.5 mg/L but less than or equal to 2 mg/L. Materials whose LD<sub>50</sub> for acute dermal toxicity is greater than 40 mg/kg but less than or equal to 200 mg/kg. Materials whose LD<sub>50</sub> for acute oral toxicity is greater than 5 mg/kg but less than or equal to 50 mg/kg. Any liquid whose saturated vapor concentration at 20°C (68°F) is equal to or greater than one-fifth its LC<sub>50</sub> for acute inhalation toxicity, if its LC<sub>50</sub> is less than or equal to 3000 ppm and that does not meet the criteria for degree of hazard 4. Compressed liquefied gases with boiling points between -30°C (-22°F) and -55°C (-66.5°F) that cause frostbite and irreversible tissue damage. Materials that are respiratory irritants. Cryogenic gases that cause frostbite and irreversible tissue damage. Materials that are corrosive to the respiratory tract. Materials that are corrosive to the eyes or cause irreversible corneal opacity. Materials that are corrosive to the skin. **4** (materials that, under emergency conditions, can be lethal): Gases and vapors whose LC<sub>50</sub> for acute inhalation toxicity less than or equal to 1,000 ppm. Dusts and mists whose LC<sub>50</sub> for acute inhalation toxicity is less than or equal to 0.5 mg/L. Materials whose LD<sub>50</sub> for acute dermal toxicity is less than or equal to 40 mg/kg. Materials whose LD<sub>50</sub> for acute oral toxicity is less than or equal to 5 mg/kg. Any liquid whose saturated vapor concentration at 20°C (68°F) is equal to or greater than one-fifth its LC<sub>50</sub> for acute inhalation toxicity, if its LC<sub>50</sub> is less than or equal to 1000 ppm.

**FLAMMABILITY HAZARD: 0** Materials that will not burn under typical fire conditions, including intrinsically noncombustible materials such as concrete, stone, and sand: Materials that will not burn in air when exposed to a temperature of 816°C (1500°F) for a period of 5 minutes in accordance with Annex D. **1** Materials that must be preheated before ignition can occur. Materials in this degree require considerable preheating, under all ambient temperature conditions, before ignition and combustion can occur: Materials that will burn in air when exposed to a temperature of 816°C (1500°F) for a period of 5 minutes in accordance with Annex D. Liquids, solids and semisolids having a flash point at or above 93.4°C (200°F) (i.e. Class IIIB liquids). Liquids with a flash point greater than 35°C (95°F) that do not sustain combustion when tested using the *Method of Testing for Sustained Combustibility*, per 49 CFR 173, Appendix H or the UN *Recommendation on the Transport of Dangerous Goods, Model Regulations* (current edition) and the related *Manual of Tests and Criteria* (current edition). Liquids with a flash point greater than 35°C (95°F) in a water-miscible solution or dispersion with a water non-combustible liquid/solid content of more than 85 percent by weight. Liquids that have no fire point when tested by ASTM D 92 Standard Test Method for Flash and Fire Points by Cleveland Open Cup, up to a boiling point of the liquid or up to a temperature at which the sample being tested shows an obvious physical change. Combustible pellets with a representative diameter of greater than 2 mm (10 mesh). Solids containing greater than 0.5 percent by weight of a flammable or combustible solvent are rated by the closed cup flash point of the solvent. Most ordinary combustible materials. **2** Materials that must be moderately heated or exposed to relatively high ambient temperatures before ignition can occur. Materials in this degree would not under normal conditions form hazardous atmospheres with air, but under high ambient temperatures or under moderate heating could release vapor in sufficient quantities to produce hazardous atmospheres with air: Liquids having a flash point at or above 37.8°C (100°F) and below 93.4°C (200°F) (i.e. Class II and Class IIIA liquids.) Solid materials in the form of powders or coarse dusts of representative diameter between 420 microns (40 mesh) and 2 mm (10 mesh) that burn rapidly but that generally do not form explosive mixtures in air. Solid materials in fibrous or shredded form that burn rapidly and create flash fire hazards, such as cotton, sisal and hemp. Solids and semisolids that readily give off flammable vapors. Solids containing greater than 0.5 percent by weight of a flammable or combustible solvent are rated by the closed cup flash point of the solvent. **3** Liquids and solids that can be ignited under almost all ambient temperature conditions. Materials in this degree produce hazardous atmospheres with air under almost all ambient temperatures or, though unaffected by ambient temperatures, are readily ignited under almost all conditions: Liquids having a flash point below 22.8°C (73°F) and having a boiling point at or above 37.8°C (100°F) and those liquids having a flash point at or above 22.8°C (73°F) and below 37.8°C (73°F) and below 37.8°C (100°F) (i.e. Class IB and IC liquids). Materials that, on account of their physical form or environmental conditions, can form explosive mixtures with air and are readily dispersed in air. Flammable or combustible dusts with a representative diameter less than 420 microns (40 mesh). Materials that burn with extreme rapidity, usually by reason of self-contained oxygen (e.g. dry nitrocellulose and many organic peroxides). Solids containing greater than 0.5 percent by weight of a flammable or combustible solvent are rated by the closed cup flash point of the solvent.

**FLAMMABILITY HAZARD (continued): 4** Materials that will rapidly or completely vaporize at atmospheric pressure and normal ambient temperature or that are readily dispersed in air and will burn readily: Flammable gases. Flammable cryogenic materials. Any liquid or gaseous materials that is liquid while under pressure and has a flash point below 22.8°C (73°F) and a boiling point below 37.8°C (100°F) (i.e. Class IA liquids). Materials that ignite when exposed to air. Solids containing greater than 0.5 percent by weight of a flammable or combustible solvent are rated by the closed cup flash point of the solvent.

**INSTABILITY HAZARD: 0** Materials that in themselves are normally stable, even under fire conditions: Materials that have an estimated instantaneous power density (product of heat of reaction and reaction rate) at 250°C (482°F) below 0.01 W/mL. Materials that do not exhibit an exotherm at temperatures less than or equal to 500°C (932°F) when tested by differential scanning calorimetry. **1** Materials that in themselves are normally stable, but that can become unstable at elevated temperatures and pressures: Materials that have an estimated instantaneous power density (product of heat of reaction and reaction rate) at 250°C (482°F) at or above 0.01 W/mL and below 10 W/mL. **2** Materials that readily undergo violent chemical change at elevated temperatures and pressures: Materials that have an estimated instantaneous power density (product of heat of reaction and reaction rate) at 250°C (482°F) at or above 10 W/mL and below 100 W/mL. **3** Materials that in themselves are capable of detonation or explosive decomposition or explosive reaction, but that require a strong initiating source or that must be heated under confinement before initiation: Materials that have an estimated instantaneous power density (product of heat of reaction and reaction rate) at 250°C (482°F) at or above 100 W/mL and below 1000 W/mL. Materials that are sensitive to thermal or mechanical shock at elevated temperatures and pressures. **4** Materials that in themselves are readily capable of detonation or explosive decomposition or explosive reaction at normal temperatures and pressures: Materials that have an estimated instantaneous power density (product of heat of reaction and reaction rate) at 250°C (482°F) of 1000 W/mL or greater. Materials that are sensitive to localized thermal or mechanical shock at normal temperatures and pressures.

## FLAMMABILITY LIMITS IN AIR:

Much of the information related to fire and explosion is derived from the National Fire Protection Association (NFPA). **Flash Point** - Minimum temperature at which a liquid gives off sufficient vapors to form an ignitable mixture with air. **Autoignition Temperature:** The minimum temperature required to initiate combustion in air with no other source of ignition. **LEL** - the lowest percent of vapor in air, by volume, that will explode or ignite in the presence of an ignition source. **UEL** - the highest percent of vapor in air, by volume, that will explode or ignite in the presence of an ignition source.

## TOXICOLOGICAL INFORMATION:

**Human and Animal Toxicology:** Possible health hazards as derived from human data, animal studies, or from the results of studies with similar compounds are presented. Definitions of some terms used in this section are: **LD<sub>50</sub>** - Lethal Dose (solids & liquids) which kills 50% of the exposed animals; **LC<sub>50</sub>** - Lethal Concentration (gases) which kills 50% of the exposed animals; **ppm** concentration expressed in parts of material per million parts of air or water; **mg/m<sup>3</sup>** concentration expressed in weight of substance per volume of air; **mg/kg** quantity of material, by weight, administered to a test subject, based on their body weight in kg. Other measures of toxicity include **TDLo**, the lowest dose to cause a symptom and **TCLo** the lowest concentration to cause a symptom; **TDo**, **LDLo**, and **LDo**, or **TC**, **TCo**, **LCLo**, and **LCo**, the lowest dose (or concentration) to cause lethal or toxic effects.

**Cancer Information:** The sources are: **IARC** - the International Agency for Research on Cancer; **NTP** - the National Toxicology Program, **RTECS** - the Registry of Toxic Effects of Chemical Substances, **OSHA** and **CAL/OSHA**. IARC and NTP rate chemicals on a scale of decreasing potential to cause human cancer with rankings from 1 to 4. Subrankings (2A, 2B, etc.) are also used. **Other Information:** **BEI** - ACGIH Biological Exposure Indices, represent the levels of determinants which are most likely to be observed in specimens collected from a healthy worker who has been exposed to chemicals to the same extent as a worker with inhalation exposure to the TLV.

## REPRODUCTIVE TOXICITY INFORMATION:

A **mutagen** is a chemical that causes permanent changes to genetic material (DNA) such that the changes will propagate through generational lines. An **embryotoxin** is a chemical that causes damage to a developing embryo (i.e., within the first eight weeks of pregnancy in humans), but the damage does not propagate across generational lines. A **teratogen** is a chemical that causes damage to a developing fetus, but the damage does not propagate across generational lines. A **reproductive toxin** is any substance that interferes in any way with the reproductive process.

## ECOLOGICAL INFORMATION:

EC is the effect concentration in water. **BCF** = Bioconcentration Factor, which is used to determine if a substance will concentrate in lifetimes which consume contaminated plant or animal matter. **TL<sub>m</sub>** = median threshold limit; Coefficient of Oil/Water Distribution is represented by **log K<sub>ow</sub>** or **log K<sub>oc</sub>** and is used to assess a substance's behavior in the environment.

**ACGIH:** American Conference of Governmental Industrial Hygienists, a professional association which establishes exposure limits.
